1 **α-Bisabolol**

A sesquiterpene alcohol with a fragrance that can be described as floral, peppery, sweet and clean. Found in chamomile, figwort, yarrow, skullcaps, lavender, ironwort, germander...etc.

2 **Guaiol**

A sesquiterpene alcohol with a fragrance that can be described as floral, piney, herbal and woody. Found in guaiacum, cypress pine, ginseng, melaleuca, goatweed, incense grass...etc.

3 **Nerolidol**

A sesquiterpene alcohol with a fragrance that can be described as floral, citrusy, waxy, herbal and woody. Found in bitter orange, ginger, lavender, jasmine, tea tree, lemongrass, lady of the night...etc.
